#### **Perspectives from the Sports Betting C-Suite**



#### **Addressing and Responding to Gambling Prohibitionists**



Museum Island is a UNESCO world heritage site and is home to the city's most important art exhibition centers including the Bode (shown), the Altes Museum (Old Museum), and the Alte Nationalgalerie (Old National Gallery). The collections in these buildings encompass more than 6,000 years of art and cultural history.
- 4. The Reichstag is home to the Berlin Parliament and was modeled after Memorial Hall in Philadelphia. Its unique glass dome sits directly above the debating chamber and the building has a considerable art collection.
- 5. The **Tiergarten's** green lawns and forested grounds were originally royal hunting grounds until they were turned into a city park that includes memorials, an English garden and more.
- 6. Remnants of the Berlin Wall can be found throughout the city including in Potsdamer Platz directly opposite The Ritz-Carlton hotel. When walking through the city, be on the lookout for both freestanding segments and plaques embedded in streets and sidewalks tracing where the Wall once stood.
- 7. Charlottenburg Palace was built by Prussian head of state Frederick I around 1700 for his wife Queen Sophie Charlotte and is surrounded by picturesque gardens next to the Spree River just outside Berlin.
- 8. Checkpoint Charlie is a reminder of the former border crossing, the Cold War and the nearly 30-year partition of Berlin. The Checkpoint also witnessed many East Berlin escape attempts and an open air exhibit nearby that tells the story of those who failed and succeeded.






#### Bill Gantz










# Bringing joy to life through the power of play







Since it was founded in 1980, the International
Association of Gaming Advisors (IAGA) has
provided a relevant, collaborative forum for
discussing key issues that affect global gaming today.
Supported by a membership that includes the industry's
leading attorneys, senior executives, financial advisors,
regulators, consultants and academics, our purpose is
to connect expert advisors through shared experiences
and education to influence the advancement of global gaming.

Originally established as the National Association of Gaming Attorneys (NAGA), IAGA was founded in 1980 in Nevada by several notable gaming attorneys to create an association that would "unite in common organization those professionally engaged in the gaming industry, to facilitate negotiations in the gaming industry and protect and promote the mutual interests of the corporation's members and to promote and encourage education in the gaming industry." The association soon drew the attention of gaming attorneys beyond Nevada who wanted to support a forum where industry legal issues could be addressed, and NAGA's membership grew to include attorneys from the United States, the United Kingdom, France and other international areas where gaming was legally regulated. As a result, and to recognize the organization's growing international membership, in 1985 NAGA evolved into the International Association of Gaming Attorneys (IAGA) and held its first international conference in Monte Carlo.

As IAGA's annual conferences expanded beyond Europe and the US, reflecting the industry's globalization and a growing international footprint, the issues and strategies IAGA addressed required more than just legal expertise. 


